TERMS OF GUARANTEE, BUYER AND BREEDER OPTIONS AND RESPONSIBILITIES

**IF FOR ANY REASON YOU NO LONGER WANT YOUR PUP CALL ME FIRST!**

BUSTIN' WATER KENNELS RESERVES THE RIGHT OF FIRST CHANCE TO BUY BACK ANY DOG!

**Guarantee is void if the dog has been sold, bred, or injured! Proof that the dog had been given a quality food throughout its lifetime is also required to keep this guarantee valid!**

The dog's hips are guaranteed to be OFA certifiable (Fair, Good, or Excellent), and elbows normal at 24 months of age. X-rays must be taken at buyer's expense by a **Board-Certified Veterinarian** by 30 months of age, and evaluated by the Orthopedic Foundation for Animals. If the buyer is not satisfied with the results, the buyer must notify the breeder and supply a copy of Board-Certified reports within 7 days of diagnosis.

The dog's eyes are guaranteed to pass a CERF exam, at buyer's expense and attain a number, including breeder options. Diagnosis must be made by a **Board-Certified Veterinary Ophthalmologist** by 30 months of age, as evaluated by the Canine Eye Registration Foundation. **If a dog is able to get a CAER number, including breeder options, eye guarantee is fulfilled.** If the buyer is not satisfied with the results, the buyer must notify the breeder and supply a copy of Board-Certified reports within 7 days of diagnosis.

All veterinarian, X-ray, and other test expenses are the buyer's responsibility.

If dog is found to be defective as described above:

The dog may be returned to the breeder (at buyer's expense) with AKC papers signed over to the breeder. Breeder (at their discretion) will either refund the entire purchase price of the dog or replace the dog with a puppy of a comparable breeding. Time frame for said replacement will be agreed upon before the dog is returned.

Buyer may keep the dog. In order to ensure the dog will not be bred, buyers must have the dog spayed or neutered. Breeder will refund 50% of the purchase price after receiving a veterinary certificate providing proof of neutering. Neutering is to be at the expense of the buyer.

Buyer has one week from the date of purchase to have the puppy examined by a veterinarian of the buyer's choosing. If the vet finds any problem, which concerns the buyer to the extent that he/she no longer wants the puppy, the puppy may be returned to the breeder, at buyer's expense. Within one week of receipt of puppy, Bustin' Water Kennels has the right to have the dog examined by a veterinarian of their choice, at buyer's expense, to ensure proper care of puppy while under control of the buyer. Upon confirmation of proper care, the breeder will refund the entire purchase price within two weeks of receipt of the puppy.

**IF THE BREEDER'S CHOICE VET FINDS THE DOG HAS BEEN MISTREATED OR INJURED AFTER TIME OF PURCHASE NO REFUND WILL OCCUR AND PUPPY WILL NOT BE RETURNED TO BUYER AND ALL AKC PAPERWORK MUST BE RETURNED TO BUSTIN' WATER KENNELS WITHIN 2 WEEKS!**
